The book is valuable assistance to national and global policymakers, military authorities, the ICRC, International Organizations including the United Nations, NGOs, academicians, and students for varied purposes. It has compiled a comprehensive study of the IHL practice in India, along with a detailed analysis of the case laws and legislation, The book is a significant addition to the literature on IHL, especially in an Indian context. It would add a corpus to the ongoing IHL dissemination efforts in India and the region.
